- Review drinking water and waste water safety plans in line with policies and procedures, risk assessments and the South Island work programme
- Provide feedback to suppliers orally and in writing
- Set up and administer supplier compliance monitoring arrangements for drinking water suppliers in the South Island
- Respond to notifications of exceedances of the Drinking Water Quality Assurance Rules and Standards, and inquiries
- Actively participate in responding to out of hours notifications and events through the on-call roster
- Actively participate in communities of practice, enabling yourself and others to learn and continuously improve.

Relationship Management

- Regulate central and local government in its provision of drinking water across the South Island (and where required other water services)
- Develop and maintain effective working relationships with internal stakeholders to achieve Taumata Arowai outcomes
- Develop and maintain effective working relationships with drinking water suppliers, regional councils as the consent authorities for wastewater, and key external stakeholders throughout the South Island to achieve the outcomes of Taumata Arowai
- Develop Māori-Crown relations capability and confidence in te reo Māori, and upholding Te Tiriti o Waitangi
- Contribute to the delivery of response activity in Taumata Arowai as needed
